**NATIONAL CONSTITUTION CENTER NOW OFFERING CONTINUING LEGAL EDUCATION CREDITS IN-PERSON AT TOWN HALL PROGRAMS AND ON-DEMAND**

***Programs available for Pennsylvania CLE credit this fall; available for New York, California, Texas, Florida, and Illinois CLE credit in January 2018***

Philadelphia, PA (November 13, 2017) – The National Constitution Center, through the American Bar Association, is now offering Continuing Legal Education credit for select *America's Town Hall* programs. These CLE programs, which can be attended in-person or on-demand online, are designed to provide affordable, scholarly programming while serving the education needs of the legal community across the United States. The programs are eligible for varying CLE credits, subject to specific state bar requirements.

Lawyers in Pennsylvania can earn CLE credits starting now. On November 16, the National Constitution Center will host a [Town Hall program with leading scholars and federal judges](#), including U.S. Court of Appeals Chief Judge Robert A. Katzmann of the Second Circuit and Judge Jeffrey S. Sutton of the Sixth Circuit, on the constitutional vision of Alexander Hamilton, exploring his views on presidential, congressional, and judicial power in America. The program is available for (2.5) CLE credits in PA. Other in-person CLE program highlights for [fall 2017](#) include a discussion on emancipation featuring renowned Civil War and Reconstruction historians David Blight, Eric Foner, and Thavolia Glymph (1 CLE credit available), and a Bill of Rights Day Symposium, which has been approved for (3) credits of CLE in Pennsylvania.

The National Constitution Center is also offering Pennsylvania CLE credits through on-demand programs, which are available 24/7.
